Candidates will be allowed to mark their preference only against the vacancies for which they are eligible as per the details provided in the application form and the eligibility criteria mentioned in this advertisement. Applicants are advised to carefully think and indicate their order of preference. Preference once submitted shall be deemed final and under no circumstance will the candidates be allowed to change their order of preference after final submission of application and the preference shall be subject to the candidates fulfilling the eligibility criteria/physical standards etc prescribed for the respective posts. The merit list of the candidate shall be determined as per order of preference indicated by the candidate for particular post(s).

**1. EXAMINATION FEES AND MODE OF PAYMENT:-**

- i. A Non-Refundable Fee of ₹ 150 for APST candidates and ₹ 200 for GENERAL candidates (to be paid online only).
- ii. Persons with Disabilities (PwD) are exempt from paying the fees.

**2. ELIGIBILITY CRITERIA: -**

- i. The candidate must be a citizen of India.
- ii. The educational qualification, age, experience as stipulated in the advertisement shall be determined as on the closing date of submission of application.

**3. SCHEME OF EXAMINATION:-**

The examination will be of 3 (three) stages for Post codes 4/23, 5/23 and 6/23. For post codes 7/23, 8/23 and 9/23 the examination shall be of 1(one) stage only.

**Stage-I : Physical Standard Test (PST) and Physical Efficiency Test (PET)**

- i. The candidates for post codes 4/23 (Constable (AAPBn/Civil Police/IRBn)), 5/23 (Constable) and 6/23 (Fireman) will have to qualify PST and PET as mentioned against each post code at pages 4 and 5 of this advertisement.
- ii. The Ex-servicemen candidates are exempted from appearing the Physical Efficiency Test (PET). However, they will have to appear and qualify the Physical Standard Test (PST).

**Stage- II : (Objective Type Multiple Choice Questions) - 300 Marks**

The test will comprise of the following subjects:-

**(a) General English – 100 marks (50 questions of 2 marks each):-**

**Syllabus:-**In addition to testing of candidate's understanding and comprehension of the English language, questions on its vocabulary, Grammar, Sentence Structure, Synonyms, Antonyms and its correct usage etc would also be covered.

**(b) Elementary Math - 100 marks (50 questions of 2 marks each):-**

**Syllabus:-**The test of Arithmetical and Numerical abilities will cover number systems including questions on Simplification, Decimals, Data Interpretations, Fractions, LCM, HCF, Ratio and Proportion, Percentage, Average, Profit and Loss, Discount, Simple and Compound Interest, Mensuration, Time and Work, Time and Distance, Tables and Graphs etc.

**(c) General Knowledge – 100 marks (50 questions of 2 marks each):-**

**Syllabus:** - Questions will be designed to test the ability of the candidates General Knowledge of the environment around him/her and its application to society. The questions will be designed to test knowledge of Current Events and of such matter of everyday observation as may be expected of an educated person. The Test will also include questions relating to History, Polity, Constitution, Sports, Art and Culture, Geography, Economics, Everyday Science, Scientific Research, National/International Organizations/Institutions etc. State specific questions may also be asked.

➤ The test will be of Objective Type Multiple Choice Questions comprising of 150 questions as mentioned above. Each question will carry 2 (two) marks. The candidate will have to complete the test in 03 (three) hours.

➤ A candidate must secure a minimum of 33% in each subject in the written examination paper. The candidate securing less than 33% of marks in any of the subject shall be deemed not eligible for selection. **There is no negative marking.**

### Stage- III : Medical Fitness Test

- i. The candidates for post codes 4/23 (Constable (AAPBn/Civil Police/IRBn)), 5/23 (Constable) and 6/23 (Fireman) will have to qualify the medical fitness test as mentioned against each post code at pages 4 and 5 of this advertisement.

### **NOTE:-**

- Stage I (PST/PET) and Stage III (Medical Fitness Test) shall be of Qualifying nature only.
- Other details, if any will be informed in the official website.
- The Final merit shall be prepared on the basis of marks secured in written examination only.

- ii. Matriculation certificates issued by the Board/University for proof of date of birth.
- iii. APST Certificate (if applicable).

- v. Intimation letter to HoD for those who are in regular Govt. Service.
- vi. PwD certificate in case of vacancy under PwD quota.
- vii. Discharge book and Pay and Pension Order (PPO) for Ex-Servicemen.
- viii. Admit Card and printout of online application form.
- ix. Any other documents as may be relevant.

➤ The shortlisted candidates will be required to submit legible self-attested copies of the documents and Admit Card along with the hard copy of print out of online application form at the time of verification of





documents (*any information contained in the attached certificates shall not be considered unless it is claimed in the application form*).

➤ Shortlisted candidates for document verification will have to upload copies of the above-mentioned documents on the APSSB portal when notified to do so. The candidates will also have to produce the above-mentioned Certificates/ Documents and mark sheet, both in original and photocopies, during document verification on the date scheduled for document verification, failing which his/her candidature will be summarily rejected and final merit list shall be prepared excluding such candidates who failed to produce required documents during verification process. Candidates may duly take notice that no additional time shall be given for production of documents.

**NOTE:-**

- i. There is no provision of re-evaluation /re-checking of Answer Sheet /Answer Scripts in respect of the examinations conducted by APSSB.
- ii. The APSSB reserves the right to cancel/withdraw any question/questions from the Test.
- iii. The Board makes provisional selection of the candidates on the basis of information provided in the application and documents/certificates provided by the candidate at the time of submission of documents and recommend the same to the indenting/ user department. Further, the Appointing Authority i.e. the indenting/user department verifies and satisfies itself about the authenticity of documents/certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional selection of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
- iv. The Board reserves the right to conduct medical test for examining the candidates belonging to PwD category if it deems necessary.

## 8. CENTRES OF EXAMINATION:-

i. A candidate must give option for 03 (three) centres, in the order of priority, from the undermentioned list of centres. No request for change of centre will be considered later under any circumstance. Hence, the candidates should select the centres carefully, and indicate the same correctly in their applications:

ii. The Board will endeavour to accommodate the candidates in centres opted by them. However, the Board reserves the right to cancel any Centre and ask the candidates of that centre to appear from another centre. Board also reserves the right to divert candidates of any centre to some other Centre to take the examination without citing any reasons.

## 9. GENERAL INSTRUCTIONS FOR CANDIDATES:-

- i. The vacancies published are provisional and subject to change. The Board reserves the right to increase or decrease the vacancies for any post in any category due to administrative reasons or in public interest. In case the vacancy position is reduced to any number or even withdrawn by the user department, the Board shall not be liable to compensate the applicant for any consequential damage/loss.
- ii. The Board reserves the right to reject the candidature of any candidate at any stage of recruitment.
- iii. The Board reserves the right to cancel a part or entire process of examination or a part of it due to administrative reason(s) and in case of unfair means, cheating or other irregularities / malpractice noticed by the Board. The Board also reserves the right to cancel or set up a new examination centre and divert the candidates to appear at that examination centre, if required.
- iv. The Board reserves the right to cancel any centre of exam and ask the candidates of that centre to appear at another centre. The Board also reserves the right to direct the candidates of any centre to another centre to take the exam. **No request for change in date, time and centre of exam will be accepted under any circumstances.**
- v. The Board reserves the right to change or make amendment in the examination scheme at any time before the examination, if so required.
