However bench mark disability candidates will have to pay processing fees of Rs.2500/-.

- 7) Compulsory Kannada Language Exam As specified in **sub-rule (2) of Rule 3 of the Karnataka Education Department Services (Collegiate Education Department) (Recruitment of the posts of principal (UG) (Special) Rules, 2020**, any candidate shall not be eligible for selection unless he/she has qualified in the Kannada Language Test. The exam should consist of a question paper of maximum 150 marks. Candidates should score at least 50 marks to qualify in this paper. This question paper will be at the standard of SSLC.
 - Provided that, if a candidate has passed the SSLC examination or any equivalent examination or any examination higher than SSLC in which Kannada is the main language or second Language or an optional subject (but not one of the subject in composite paper) or has passed in Kannada medium, he/she is exempted from the Kannada language exam.
- 8) Candidates are informed to visit KEA Website http://kea.kar.nic.in for Cadre wise details of Academic Eligibility Conditions, Competitive Examination Papers and Mode of Selection and Appointment, and also the number of cadre wise and category wise vacancy positions.
