- iv) 01 marks awarded for a correct answer and a negative marking of \(^1\sqrt{4}\) marks for each wrong answer.
- v) No negative marking for the non-attempted question.
- vi) Candidates three times the number of vacancies (or less if not available) who qualify screening test will be called for department assessment.
- vii) A merit List will be prepared on the basis of combined marks of Screening Test and Assessment and candidates equal to number of vacancies available will be selected in each category.
- viii) A panel of waitlisted candidates will also be prepared equal to the number of vacancies provided such number of qualified candidates are available in each category.

- 2. Undertaking in application form must be signed by the candidate.
- 3. The institution will not be responsible for any postal delay.
